SVCL Route Map



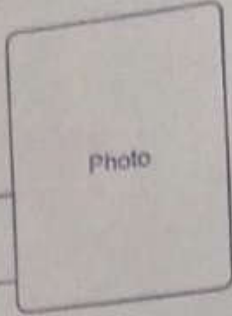
Available Facilities in SVCL:
